## 1. Introduction

Welcome to AutoCrash.ai, a SaaS platform developed by **DataVision s.r.o.**, registered in Prague 5, 15300, Slinkov 589/2, Czech Republic, ID.Nr. 27142663, and sold via **DataVision Italia Srl**, with registered office at Via Luis Zuegg 23, Bolzano, 39100, Italy, Part.IVA 03175050214, designed specifically for forensic experts specializing in accident reconstruction and analysis. AutoCrash.ai leverages advanced AI technology to provide accurate and efficient solutions for evaluating vehicle damage, bodily injury potential, and accident circumstances. By accessing or using AutoCrash.ai (the "Service"), you agree to comply with these Terms of Use. These terms apply to both demo and full-featured users. This agreement is governed by Italian law. If you do not agree with these terms, please discontinue your use of the Service.

## 2. Account Registration & Eligibility
